Chairman's Report



Somebody recently informed me that the Civic Trust would have little to do now that all the heritage buildings had been demolished. This sombre comment showed little regard for the nearly 50 years of work of the Trust. While it is heritage battles that have given the Trust its highest profile in recent years, there are many other things that we stand for. Public participation in the planning process was a principal concern of the Trust founders in the 1960s.

We are distraught about the loss of so much of our built heritage. More buildings are listed each week by CERA for demolition. Where retention may have been possible, the financial imperatives and mindless haste has pushed owners into destruction. It is obvious that there will not be a lot of the central city left. The difficulty will then be that there is little to graft the recovery on to, heritage or not.

The Board is looking at reprinting *City and Peninsula*, jointly published in 2007 with the Akaroa Civic Trust. This book remains the best record of the heritage of Christchurch and Banks Peninsula lost in the earthquakes. We need external funding as the Trust is not in a position to underwrite the costs. There is also still a debt of \$40,000 from defending the Arts Centre against the Music School proposal.

The City Council will release its draft Central City Plan for public comment in August. This will be the first opportunity to see if there is a vision that builds on the identity of Christchurch. The Board will be making a submission and would welcome any input from members. Please make your own submissions.

The AGM and Awards will happen over the next couple of months and I invite you all to be involved in these events.

This is my last newsletter as Chair of the Trust, although I intend to remain on the Board. It has been a privilege to hold this position and I know that we will continue to make a contribution to this great city in a considered way.
